AFTER EVERY RESCUE, THE TEAM PROVIDES INITIAL SERVICES THROUGH LOCAL AGENCIES, INCLUDING MEDICAL EXAMINATIONS AND IDENTIFICATION DOCUMENTS. EVERY CHILD IMMEDIATELY GOES ON THE MISSING CHILD REGISTRY IN ORDER TO FIND ANY FAMILY MEMBERS WHO MAY BE LOOKING FOR THEM.
